However, beneficiaries can go to TRICARE-approved outside pharmacies for this service. For children under the age of 12, contact the information line at 762-408-2273 to leave a message for your provider to receive a written prescription. The pharmacy pilot program to drop-off prescriptions is fully functional. This allows patients who check-in at the pharmacy desk before 1200 to pick up their prescriptions after 1500 the same day. Prescriptions dropped off after 1200 are available for pick-up the next day. Furthermore, a pharmacy ticket kiosk will be available by the end of next week. We now have three new pediatricians on staff who have available appointments.
