Briefly Describe the proposed business activity:

Following are the rules to ensure that an HBB does not negatively affect the safety, community tranquility, or the good order and discipline on Fort Benning. The business owner acknowledges that he/she meets the following conditions:

- HBB owner must obtain the requisite permissions, licenses (if applicable), and liability insurance prior to opening/operating.
- HBB owner is responsible for any damages to third parties arising from the conduct of his/her business.
- HBB owner providing child care must register with the installation Child & Youth Services office as part of the Family Child Care (FCC) provider system.
- HBB owner is required to comply with and is subject to annual inspection by FB/MWR Safety, Fire, Veterinary Services, and Preventative Medicine for compliance with applicable laws, codes, regulations and requirements.
- An HBB involved in food preparation need to be approved by Martin Army Community Hospital Preventative Medicine. The applicant must provide documentation that states the HBB meets all applicable food safety and sanitation conditions.
- The residential character of the property shall be maintained. The HBB may not occupy more than 25 percent of the home's gross floor area. Parts or materials related to the HBB shall be screened from public view and will be limited to the interior of the structure or the side and rear yards of the property.
- Customers may only patronize an HBB between 0800 and 2000.
- Noise, vibrations or odors shall not be detectable beyond the property line.
