- j. Assignment of desk space for interviews, except for specific, prearranged appointments. During appointments, the agent must not display desk or other signs announcing the name of the company or product affiliation.
- k. Use of the "Benning Bulletin" or any other notice, official or unofficial, announcing the presence of an agent and his availability.
 - 1. Distribution of literature other than to the person being interviewed.
- m. Wearing of nametags that include the name of the company or product that the agent represents.

- n. Offering of financial benefit or other valuable or desirable favors to military or civilian personnel to help or encourage sales transactions. This does not include advertising material for prospective purchasers (such as pens, pencils, wallets, and notebooks, normally with a value of \$1 or less).
- o. Use of any portion of installation facilities, to include quarters, as a showroom or store for the sale of goods or services, except as specifically authorized by regulations governing the operations of exchanges, commissaries, nonappropriated fund instrumentalities, and private organizations. This is not intended to preclude normal home enterprises, providing State and local laws are complied with.
- p. Advertisements citing address or telephone numbers of commercial sales activities conducted on the installation.
- q. Under no circumstances will agents have allotment forms in their possession or attempt to assist or coordinate the administrative processing of such forms.
- r. Commercial solicitation in training units (deferred until after IET and until assignment to their first duty station), to include the $75^{\rm th}$ Infantry Ranger Regiment.

3. I am aware that:

- a. Authority to solicit on Fort Benning does not constitute official endorsement of myself, my company, or the policy, goods, services, or commodities offered for sale. Furthermore, it does not constitute recommendation of myself, my company, or the policy, goods, services, or commodities offered for sale.
- b. I will abide by the Department of the Army's policy concerning equal opportunity and race relations AR 600-20. I will provide equal opportunity and treatment for military personnel and their dependents while soliciting on Fort Benning, regardless of race, color, religion, national origin, age, or sex. Failure to do so will result in suspension/withdrawal of the privileges to solicit on Fort Benning for myself and/or my company.
- c. If I am soliciting insurance, I am required to leave with each individual PVT-PFC and the unit insurance officer or counselor information regarding the policy applied for by completing a Commercial Insurance Solicitation Record (DA Form 2056).
