WAIVER, RELEASE OF LIABILITY & ASSUMPTION OF RISK**

I desire and voluntarily request to participate in Event(s) with Sportsmen's Alliance Foundation, Sportsmen's Alliance Foundation Trailblazer Adventure Program and Sportsmen's Alliance ("Event" date & location) _____ and/or I desire and voluntarily request that the Minor named below ("Minor Participant") participate in the Event. I acknowledge and understand that participating in the Event entails known and unanticipated risks that could result in serious bodily injury, death or damage to property. Specific risks/hazards involved in participating in this Event include but are not limited to the following: (1) serious physical injury or death sustained while participating in shooting, archery, outdoor, or other physical activities; (2) auto accidents while traveling to and from the Event location or while traveling at the Event location; (3) dehydration or fatigue; and (4) medical problems such as illness, allergies, heart condition, etc.

With these understandings, and in consideration of being permitted to participate in this Event, I agree to the following (1) should I observe any conduct that creates a threat to the safety of others to immediately report it to those in charge of the event, and (2) I, for myself and, my spouse, my parents, guardians, my heirs, executors, administrators, assigns, and anyone who may be representing me:

HEREBY RELEASE, WAIVE, HOLD HARMLESS, DISCHARGE FOREVER, COVENANT NOT TO SUE, INDEMNIFY AND HOLD HARMLESS Sportsmen's Alliance Foundation, Sportsmen's Alliance Foundation Trailblazer Adventure Program and Sportsmen's Alliance, and their directors, officers, and employees, and their subsidiaries, affiliates, directors, officers, employees, agents and/or volunteers ("Released Parties") FROM ALL LIABILITY FOR ANY AND ALL LOSS, DAMAGE, INJURY TO PROPERTY, PERSONAL INJURY, DEATH OR OTHERWISE, arising from or in any way connected to my, and/or the Minor Participant's, participation in the Event, however caused and regardless of whether such loss, damage, injury or otherwise arises out of act, or omission or ordinary negligence on the part of the Released Parties and any other party that may be associated with this Event, whether it arises upon any theory of strict liability or otherwise.

2. HEREBY ASSUME FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, OR PROPERTY DAMAGE, arising out of my, and/or the Minor Participant's, participation in this Event whether caused by ordinary negligence of the Released Parties and any other party that may be associated with this Event.

I certify that I have adequate insurance to cover any injury or damage that I, and/or the Minor Participant, may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I, and/or the Minor Participant may have.

Consent to, and grant to, the Released Parties the unrestricted right and permission to copyright and use, re-use, and republish video footage, photographic portraits or pictures of me, or my likeness, in which I may be included intact or in part, composite or distorted in character or form, without restriction as to changes or transformations in conjunction with my own or a fictitious name, or reproduction thereof in color or otherwise, made through any and all media now or hereafter known for illustration, art, promotion, advertising, trade, or any other purpose whatsoever. I hereby relinquish any right that I may have to examine or approve the completed product or products or the advertising copy or printed matter that may be used in conjunction therewith or the use to which it may be applied and agree to release, discharge and agree to hold harmless the Released Parties from any liability that may occur or be produced in taking of said video or photographs or in any subsequent processing thereof, as well as any publication thereof, including without limitation any claims for libel or invasion of privacy.
