- 1. The Fort Benning Garrison Community Activities and Resources Exchange (CARE) meeting convened at 0930 on 6 August 19 at Army Community Service (ACS), Building 7.

3. The CARE panel and briefers provide valuable information for leaders to share with their units. The panel and briefers are available after the meeting to answer questions. "Back to School" was today's topic.

4. Community Forum:

a. School Liaison Office (SLO) – School Liaison Officers Ethan Branch and Marcus DuBose briefed the School Liaison Office's support of the CYS mission by leveraging community resources to reduce the impact of the mobile military lifestyle on children and youth. Those on the housing waitlist will receive a 90-day waiver letter from housing that will allow students to enroll into DoDEA schools. This letter gives 90 instructional days that starts the first day of school. Families who live off-post cannot attend on-post schools unless they have the 90-day waiver letter. Bus transportation is available for all Fort Benning students regardless of having a bus pass or not. In addition, the state of Alabama offers middle and high home schooled students opportunities for extracurricular activities. In the state of Georgia, each district has different requirements for extracurricular activities for home schooled students. - b. Child & Youth Services (CYS) Ms. Daphne Montgomery briefed Middle School & Teen (MS&T) now offers before school care; fees based on income. The MS&T Program offers a free open recreation after school service for Faith Middle School students. School Age Care provides before and after school care; fees based on total Family income. Both MS&T and SAC provide transportation to all on-post schools. Georgia Pre-K Program offers full-day care 0830 1500. Currently, there is a waitlist at all locations. Hourly care is available Tuesdays and Thursdays 0800 1700 which includes a fee of \$5 per hour per child 6 weeks to 5 years (non-kindergarten). Reservations are available up to three weeks in advance. Hourly services are available to school age dependents through SAC. - c. Military Student Coordinator Ms. Darlene Register briefed Bill 59 that states new Families who provide documentation of residence within the district can enroll in the school district for 30 days with a possible extension of an additional 30 days. Muscogee County middle and high schools offer fine arts and club sports. Columbus High School is the first military flagship awardee in the state of Georgia. - d. School Military & Family Life Counselor (MFLC) Ms. Kimberly Pritchard briefed that the MFLC program provides short term, situational, and problem solving counseling to service members and their Families. The MFLCs do not keep records or documentation on file. The MFLCs offer mobile counseling services in public areas throughout the schools as well as on or off military installations. In addition, counselors are located in DoDEA schools and units. For more information, see the CARE slides for contact information.

Tutor.com Ms. Julie Yerkes briefed attendees of online tutoring services offered to K-12 military dependents of active duty service members, active full-time and deployed National Guard and Reserve personnel in all branches. - b. Martin Army Community Hospital (MACH) Colonel Hoffman briefed the success of the back-to-school sports physicals. See the CARE flyers for additional information. Effective 13 Sep 19, pharmacy hours will change to 0800 1730.
- c. Villages of Benning Mr. Snyder briefed that due to the increase of permanent party arriving to Fort Benning, there are various waitlists for all Fort Benning Villages. All housing will receive RSI checks before any new tenant moves in. Due to changes in K&E policies wait times have increased. There will be incentives offered for partial turn moveins. There is a 19-day turnaround for all housing excluding historical housing. Historical housing renovations are taking 8 10 weeks depending on severity of issues. Work order call-ins for vacant housing are accepted Monday Friday 0800 to 2000. Upcoming events include Breakfast on the Go, 10 Sep 19 and Tailgate Football Party, 21 Sep 19.
