- 3. The CARE panel and briefers provide valuable information for senior spouses and leaders. Today's topic was "School Resources."
- 4. Community Forum:
- a. Department of Defense Education Activity (DODEA) Dr. Lisa Coleman briefed the precautions and protocols in place for schools. She spoke on the two learning options, Fulltime In-person School, and Full-time Virtual Learning. DODEA Schools begin 17 Aug, but due to HPCON Charlie, students enrolled in In-person School will not report to school but participate in remote learning until HPCON level downgrade. Students registered for Virtual Learning will continue participating in that option until the end of the semester. - b. Chattahoochee County Dr. Kristie Brooks briefed COVID-19 measures in place for the upcoming school year for Chattahoochee County School District. - c. Muscogee County Dr. David Lewis briefed the three models of learning in place for the upcoming school year. All are required to attend virtual class for the first three and half weeks of school. Model one consists of full-time classroom learning. Model two consists of full virtual learning. The third model is the choice model which allows parents to choose whether they prefer the virtual or in-person models. School special resources will still be available to the students. All students and faculty must have temperature checked and masks on before entering the building. - d. Harris County Ms. Shelia Baker briefed the instructional options given to parents for the upcoming school year. Harris County Schools start 17 Aug. Students' options are traditional inperson learning, virtual learning, and home school learning. Pre-K students are limited to utilizing the traditional in-person learning option. ## 5. Panel Updates:

- a. Directorate of Emergency Services (DES) Major Yolanda Edwards cautioned attendees of an influx of fraud associated with financial relief pertaining to COVID-19 and break-ins occurring off post. She urged individuals to be aware of their surroundings, keep personal items out of plain view in their vehicles and make sure their belongings are secure. - b. Martin Army Community Hospital (MACH) LTC Steven Oliver briefed on the continued restrictive visitation policy of one guest per visit. MACH asks families to not visit the hospital if sick and to call the nurse advice line at 1-800-874-2273 or the MACH COVID-19 number at 762-408-2819. - c. Villages of Benning Ms. Denise Bleiler briefed the requirement of renters insurance to cover personal belongings in the event of a disaster. She spoke on Villages of Benning filming a video for families explaining what is required during the moving out process. When moving out, families are required to leave homes in the same condition as received. Housing asks to call in works orders as soon as possible. She discussed the new process of completing work orders. Housing is highly occupied and Villages of Benning is working as fast as they can to move new families in.
